The number of research members decreased slightly. New Activities: Weekly photonic lunch chats on Tuesday noon and Yoga sessions on Thursday morning.

Swissphotonics is involved in 3 european projects and member in 8 organisations.

There is not yet an award for a master thesis at ETHZ but it's planned. In principal also an award for an UAS master thesis would be possible if it could be financed.
